ORDINANCE NO. 868

AN ORDINANCE ENTITLED AN ORDINANCE TO ANNEX CERTAIN LANDS THE EXISTING CORPORATE · LIMITS OF THE CITY OF BRUNSWICK UPON APPLICATION OF THE OWNERS OF SAID LANDS, TO DESCRIBE AND DEFINE THE LANDS TO BE ANNEXED, TO BRING THE SAME WITHIN THE CORPORATE LIMITS OF THE CITY SUBJECT TO ALL LAWS, ORDINANCES, RULES AND REGULATIONS GOVERNING THE CITY, TO PROVIDE AN EFFECTIVE DATE, FOR OTHER PURPOSES.

BE IT ORDAINED by the Commission of the City of Brunswick, Georgia, in Regular Meeting lawfully assembled, and it is hereby ordained by authority of the same, as follows:

SECTION 1. Those certain lands described and defined in the Property Description attached herewith and made a part of this Ordinance are hereby annexed to the existing corporate limits of the City of Brunswick and are hereby brought within the corporate limits so as to be and become a part of the incorporated area of said City, upon application of the owners of said lands.

SECTION 2. Said lands are hereby declared to be subject to all laws, ordinances, rules and regulations governing the City of Brunswick.

SECTION 3. Said lands shall be zoned General Residential (GR), that being the zoning classification heretofore designated on the Glynn County Zoning Map, and the same shall be subject to building requirements mandated by the Glynn County Flood Insurance Rate Map (FIRM) so long as the same shall remain in effect with respect to said lands.

SECTION 4. A survey of said lands filed with this Ordinance shall be deemed a part of the Ordinance.

SECTION 5. All ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed and superseded to the extent of such conflict.

SECTION 6. This Ordinance shall be of full force and effect immediately upon its adoption.

OFFICIAL MINUTES

COMMISSION OF THE CITY OF BRUNSWICK, GEORGIA REGULAR MEETING 8:30 A. M., September 7, 1988

PRESENT: His Honor Mayor Paul Warwick, Jr., Commissioners Thomas P. Williams, Homer L. Wilson, James A. Stephens and Ken Tollison.

The invocation was given by the Reverend J. W. Williams, First Friendship Baptist Church.

William A. Taylor was present to discuss his interest in the City Elections and to praise the work of Commissioners Stephens and Williams for their outstanding years of service.

Commissioner Stephens and Williams talked of their many years of service in City Government, their accomplishments and goals for the coming years.

Commissioner Stephens moved that the minutes of the meeting of August 17 and 23 be approved. Commissioner Tollison stated that a correction should be made in the paragraph adopting the resolution for assigning the City funds from the sale of the BPA to the Brunswick - Glynn County Development Authority, the vote should read 4 to 0. Motion was seconded by Commissioner Tollison and was unanimously carried.

Petition received from J. R. Miller, to retail liquors for consumption on premises at 711 Liquors, 210 -212 Monck, and having been approved by the Chief of Police and the City Manager, Commissioner Tollison moved that same be granted. Motion was seconded by Commissioner Wilson and was unanimously carried.

Petition received from Nelson Hart to retail liquors for consumption on premises at 1621 Albany and having been approved by the Chief of Police and the City Manager, Commissioner Tollison moved that request be granted and that alcoholic beverages be served in the downstairs bar. Motion was seconded by Commissioner Stephens and was unanimously carried.

Vernon Martin, Director of CAPDC appeared before the Commission to give a brief discussion on the New Regional Task Drug Enforcement Grant. Mr. Martin stated that Congress allocated funds to the State of Georgia to combat drug problems around the state. Chief Alexander and Chief Carter were in attendance at the meeting to discuss drug problems in Glynn County and the City of Brunswick and stated that they supported the said Drug Enforcement Task.

Pollowing discussion, Commissioner Wilson moved that the grant application be submitted. Motion was seconded by Commissioner Stephens and was unanimously carried.

Commissioner Tollison pointed out that the City's Law Enforcement Department does not have the necessary equipment to handle rabid animals. Commissioner Tollison moved that the City Manager be given the authorization to do whatever is necessary to handle said animals. Motion was seconded by Commissioner Stephens. In discussion, Commissioner Stephens inquired whether or not a tranquilizing device can be used to disable animals. Chief Alexander stated that the County does not use such devices to handle animals and gave reasons for same. Mayor Warwick stated that the Commission has been dancing around the animal control problem and the situation was not getting any better in the City, he then requested that a recommendation as to how to deal with said problem be presented at the next meeting. On call for the question, the motion carried unanimously.

On the matter of the cemetery lot refunds, the City Manager recommended that refunds of said lots be set at the current selling price. Hereafter, at any time there is an increase in the selling price of cemetery lots, refunds will be increased to the same amount. Commissioner Stephens moved that the City Manager's recommendation be approved. Motion was seconded by Commissioner Williams and was unanimously carried.

Following discussion, Commissioner Tollison moved that the low bid of Miles & Company in the amount of \$131,162.40 be accepted, for Water/Wastewater Project for the DNR Regional Headquarters. Motion was seconded by Commissioner Stephens and was unanimously carried.

The City Manager stated that the Park and Tree Commission recommended that a commemorative stone be erected naming the Mary Ross Waterfront Park. Commissioner Williams moved that request be granted. Motion was seconded by Commissioner Wilson and was unanimously carried.

Redemption requested in the names of present owners on the following described property acquired by the City at tax sales and on motion of Commissioner Williams, seconded by Commissioner Wilson, the Mayor was unanimously authorized to execute quit claim deeds as petitioned for upon payment of all taxes, interest and costs to wit:

Commissioner Wilson moved that the bid of Unisys Corporation in the amount of \$9,920 for a 650 LPM Printer be approved. Motion was seconded by Commissioner Tollison and was unanimously carried.

Commissioner Tollison moved that bids be opened publicly in the council room, and that the City Manager, City Clerk and Purchasing Agent be present and that said bids be reviewed and brought back to the Commission for approval. Motion was seconded by Commissioner Wilson and was unanimously carried.

The City Manager recommended that Vicki Hamilton be appointed as Personnel Director. Following discussion, Commissioner Tollison moved that the City Manager's recommendation be approved. Motion was seconded by Commissioner Wilson and was unanimously carried.

On the matter of the Waterfront Park, Commissioner Tollison moved that the City Manager and Director of Parks and Cemeteries bring back to the Commission, a plan for some developments to the said park. Motion was seconded by Commissioner Williams and was unanimously carried.

The Mayor reported that the public hearing on proposed land use plan for properties surrounding the hospital, should be rescheduled for a later date.

The City Commission set the date for Water/Wastewater Ordinance Amendments for Tuesday, September 13, at 9:00 A. M.

Commissioner Wilson reported that the City has no professional Civil Engineer on its staff and before any action is taken, the Commission would like to know if there would be any in house savings before considering an engineer. Commissioner Wilson moved that the City Manager advertise the said position of Civil Engineer. Motion was seconded by Commissioner Williams and was carried by unanimous vote.

Commissioner Wilson moved that the Mayor write the Department of Transportation to request that the spur be cleaned up. Motion was seconded by Commissioner Tollison and was unanimously carried.

Commissioner Tollison pointed out that City Hall needs to be exterminated. He recommended that the City Manager invite bids.

Commissioner Tollison moved that the City meet with the County to jointly order tax benefit study in the City and County, by the University of Georgia. Motion was seconded by Commissioner Williams and was unanimsouly carried.
